Investigation of Applicants

Each application shall be referred to the Union Beach Police Department, who shall immediately institute whatever investigation of the applicant's business responsibility, moral character, and ability to properly conduct the licensed activity he considers necessary for the protection of the public. The Union Beach Police Department shall communicate said findings in writing to the Governing Body within a reasonable time after the application has been filed. If the Borough of Union Beach decides that the applicant's character, ability, or business responsibility is unsatisfactory, or the products, services or activity are not free from fraud, they shall disapprove the application and shall refuse to issue the license and so notify the applicant. Otherwise, the Borough shall issue the license, provided the required license fees have been paid. In the event of refusal of the issuance of a license, the application may appeal to the Governing Body for a hearing. The appeal shall be filed in writing with the Borough within 14 days after notification of refusal. The Governing Body shall hold its hearing within 10 days hereafter, and its decision shall be final.
