

NOTICE TO BIDDERS

Notice is hereby given that sealed proposals will be received by the Borough of Union Beach in the County of Monmouth, New Jersey for SOLID WASTE, BULK WASTE AND RECYCLABLE MATERIALS COLLECTION AND DISPOSAL SERVICES. Bids will be opened and read in public at the Union Beach Borough Hall, 650 Poole Avenue, Union Beach Borough, New Jersey 07735 on Thursday, November 12, 2015 at 10:00 AM prevailing time.

Contract Documents for the proposed work, prepared by Edward G. Broberg, PE, Union Beach Borough Engineer, of the firm of T&M Associates, Consulting and Municipal Engineers, have been filed in the office of said Engineers at Eleven Tindall Road, Middletown, NJ 07748, and may be inspected by prospective bidders during business hours.

Bidders will be furnished with a copy of the contract documents and plans by the Engineer upon proper notice and payment of a non-refundable charge of Fifty Dollars (\$50.00) to defray the cost thereof.

Proposals must be made on the Standard Proposal Forms in the manner designated in the Contract Documents, must be enclosed in a sealed envelope bearing the name and address of the Bidder and the name of the work on the outside, addressed to the Borough Clerk, Anne Marie Friscia, 650 Poole Avenue, Union Beach Borough, New Jersey 07735 and must be accompanied by a Statement of Consent of Surety from a surety company holding a Certificate of Authorization to do business in the State of New Jersey and a bid guaranty to the Borough of Union Beach for not less than ten percent (10%) of the amount of the bid except that the bid guarantee need not exceed \$20,000.00.

Bidders must also include with their bid the following documents: Bidders Certificate of Public Convenience & Necessity, an Approval Letter issued in Conformance with NJSA 13:1 E-126, A Questionnaire setting forth qualifications, experience and financial ability and acknowledgment of receipt of addenda.

The Borough of Union Beach reserves its rights to reject any or all bids or to waive any informality and to accept the bid that, in its judgment, will best serve the interests of the Borough. The Borough reserves the right to require a complete qualifications, experience and financial ability statement from prospective bidders showing that they have satisfactorily completed work of the nature required before furnishing proposal forms of specifications, or before awarding the Contract.

The right is also reserved to reject any or all bids or to waive any informality where such informality is not detrimental to the best interest of the Borough. The right is also reserved to increase or decrease the quantities specified in the manner designated in the specifications.

Bidders are required to comply with the current requirements of N.J.S.A. 10:5-31 et. seq. (P.L. 1975, c.127 Affirmative Action); N.J.A.C. 17:27; and P.L. 1999, c.39, as amended by P.L. 2004, c.57, (NJ Contractor Business Registration Act).

Bidders are also required to comply with other provisions of Law including, but not limited to, the requirements of:

- N.J.A.C. 7:26H-6 et. seq. (Uniform Bid Specifications)
- N.J.A.C. 5:34-1. (Local Public Contracts Law)
